<p>IID02: Students will be assessed using Teacher created common formative assessments, STAR, Istation, PAST, Apex, DIBELS, and others as needed to determine the need for remediation or intervention. Remediation will be in class, in small group, individual, using adjutant personnel, or software as appropriate. Assessment data will be collected on data sheets which will follow the student to the next grade and will be reviewed by instructional teams to determine the effectiveness of instruction and to determine subsequent actions.</p>

<p>Classroom Instruction – Provide a tired system of instruction and behavior supports and interventions</p>
<p>IIIA01: All teachers will be guided by documents that align instruction, curriculum, assessment, and standards. All district and building level administrators will monitor and provide feedback for lesson plans, classroom walkthroughs, and informal assessments.</p>
